

Margaret Isobel Douglas or Hargreave

Extract from citation Coat of Arms matriculated 23.9.1996 70<sup>th</sup> page of 76<sup>th</sup> Volume of the Public Register of All Arms and Bearings of Scotland

**MISTRESS MARGARET ISOBEL DOUGLAS or HARGREAVE**, residing at Earnshaw House, 35 Copsem Lane, & ∞  
Esher, in the County of Surrey having by Petition unto the Lord Lyon King of Arms of date 1 December 1995  
**Shewn; THAT** she, the Petitioner, born Tientsin 14 December 1919 (who married 23 June 1943 John Michael, son of  
Oliver Hargreave, and has issue by him an elder son, born Lytham St. Annes in the County of Lancaster 23 March  
1944, Timothy Bruce Hargreave, a second son, born London 13 June 1948, Oliver Douglas Hargreave, and a daughter  
born London 8 May 1964, Belinda Roseanne Hargreave) is the daughter of the late Captain Robert Hinde ∞  
Douglas, sometime senior partner Goddard & Douglas, marine surveyors, Hong Kong, and his wife (married &  
Shanghai, China 16 July 1912) Sarah Jane, daughter of William Reynolds; **THAT** the Petitioner's said father  
(born Edinburgh 31 October 1871 and died Guernsey 7 January 1941) was the second son of the late Thomas ∞  
Harigad Douglas, and his wife Jane Catherine Rachel, daughter of Alexander Simpson; **THAT** the said Thomas  
Harigad Douglas was the only surviving son of James Torry Douglas, searcher of Public Records, and his wife  
(marriage contract 20 October 1831) Helen Bryden, daughter of Alexander Brown; **THAT** the said James Torry  
Douglas (born Guernsey 23 February 1804 and died Edinburgh 6 January 1877) was the second son (but no  
male descendants now survive of Archibald, his elder brother) of Major James Douglas, 7th Veteran Battalion,  
and his wife (married 1 June 1795) Janet, daughter of James Torry, Bailie of Edinburgh; **THAT** the said Major  
James Douglas (born Crawfordmuir in the County of Lanark 15 September 1751 and died Balgonie in the County  
of Fife 8 July 1820) was the eldest surviving son of David Douglas, Colonel the Scots Brigade in the Service of ∞  
Holland, and his wife (married 28 October 1750) Margaret, daughter of Thomas Bryden in Crawfordmuir; **THAT**  
the said Colonel David Douglas (born Lockerbie in the County of Dumfries 25 December 1725) was the second son  
(but no issue now survive of his elder brother James, Surgeon 66th Regiment of Foot) of Archibald Douglas of  
Morton, Surgeon in Lockerbie (who erroneously matriculated his Arms in the Public Register of All Arms and ∞  
Bearings in Scotland of date 30 June 1772 as a descendant of Sir William Douglas, son of James, 2nd Lord ∞  
Dalkeith) and his wife (married 3 August 1723) Jean, daughter of David Dickson, descended of the Dicksons of  
Hartree; **THAT** the said Archibald Douglas (born Canongate, Edinburgh 2 June 1703 and died Morton in the  
County of Dumfries 19 October 1786) was the only surviving son of James Douglas of Morton, Colonel Scots Foot Guards,  
Brigadier Dutch Highland Brigade, and his wife Jean Maxwell; **THAT** the said James Douglas of Morton (who ∞  
recorded Armorial Bearings in the said Public Register of date 14 March 1696) was the only surviving son of William  
Douglas of Morton, and his wife Esther, daughter of Sir Gilbert Eliot of Stobs; **THAT** the said William Douglas of  
Morton (who died Edinburgh aged about 80 March 1707) was the eldest son of James Douglas of Morton, and his wife
