## NEWS FROM THE AGM

The Annual General Meeting of the Clan Douglas Association of Australia was held at the President's home at Graceville on 11/Nov/2006 at 1.30pm. Many items were discussed including the following:

- Would someone living in the cities of Sydney, Melbourne, Adelaide, Perth, Hobart and Darwin please volunteer as a representative of the Clan Douglas in his/her city and state. No onerous duties are attached to the office of 'Regent'.
- 1.The Clan Douglas members of the executive have recommended that other members be asked their opinion regarding the changing of the Constitution dealing with the clauses "Office Bearers" and a "Quorom".

The Constitution states 'that only members bearing the name of Douglas or born bearing the name of Douglas may occupy the position of Patron, President and Vice President'.

Rationale: Our membership has dropped over the years and as a result of our aging executive and the busy lifestyle our younger members embrace, we may find it difficult in the future with this restrictive wording as it effectively rules out descendants in the female line who will not bear the name of Douglas.

Therefore, we ask that the clause 'that only members bearing the name of Douglas or born bearing the name of Douglas may occupy the position of Patron, President and Vice President' be deleted from the Constitution and the clause 'that any members descended from a Douglas may take the positions of Patron, President/Vice President' be inserted.

 2. That the Constitution be changed regarding a Quorom. The Constitution states 'that at all General Meetings of the Association, nine (9) members shall form a Quorom – Committee Meetings five (5) members'.

Rationale: With our aging membership, the busy lifestyle our younger members embrace and the lack of attendance at General Meetings, it is suggested that this clause be deleted and the following clause inserted: 'that at all General and Committee Meetings of the Clan Douglas Association of Australia five (5) members shall form a Quorom'

The Clan Douglas Association of Australia would appreciate members filling in the enclosed Proxy form and returning to the President so that an Extraordinary General Meeting may be held for the 24<sup>th</sup> March, 2007 prior to an ordinary meeting in order that the Constitution be changed.

- Membership fee of \$20-00 per annum will remain the same. However, if the fee isn't paid by the end of February 2007, the member will be regarded as non-financial and no further newsletters will be dispatched to that member.
- The executive committee for 2006-2007 remains the same.
- Ron Douglas Bursary for 2006 has been awarded to Thomas Brassington of Scots College, Warwick and a cheque for \$100-00 was presented to him at the School Speech Day on 17/Nov/2006. (See enclosed)
- Next AGM was set down for 11/Nov/2007.

## All Saints' Anglican Church Wickham Terrace, Brisbane

This church was used as the venue for the June 2006 'Kirkin of the Tartans'.

It seems the very early history of All Saints' Church was pretty sad with quarrelling & bickering over money, power, voting-rights which finally led to disenfranchisement of the congregation in 1862. It wasn't until 1869 that the Hon. John Douglas M.P. called and chaired an 'Indignation Meeting' which decided to ask for a statement about certain uses of moneys etc.

The idea was to extinguish the debt and to appoint 'Trustees'. The Bishop had built the original church without consulting the congregation as to the style or accommodation, yet expected the congregation to pay for it, which they did paying off the interest and principal in a short time. Their incentive for this arose from the fact that the Bishop if he so desired, could close the church for public worship and open it as a school. The Bishop was interfering in 'pew letting' and the parishioners considered also that there was a need for older men of standing to be involved in the church who would have an influence in the community.

Parliament at that time proposed a 'Public Lands Bill' which excluded the Church of England from the 'Trustees Act' and gave the Bishop full power over all church lands. A public meeting in protest declared that other churches were allowed to manage their own affairs so why couldn't Wickham Terrace? Eventually another public meeting was held and it was announced that the Bishop had appointed the Hon. John Douglas as warden representative. However, the troubles didn't stop there. According to the History of All Saints' Church Brisbane by D.L.Kessick, B.A., the Bishop retained the 'right of appointment' of the Trustees. The Rev. Shaw, the Hon. John Douglas and Mr R Phelan were appointed. There was also the question as to whether the land on which the church stood was granted under Sir Richard Bourke's Acts or under the Crown Lands Alienation Act. Things were made difficult too by the Bishop who had managed the church's finances from 1862 to 1864 and the wardens were confronted with debts and arrears of stipend. Up until the reconstruction in 1869, the church was known as the 'Brisbane Tabanacle' but after that was designated 'All Saints' Church' by the Bishop when the Foundation Stone for the new church was laid 05/Apr/1869 by the then Governor of Q'ld. Sir S.W. Blackall.

D.L.Kessick reports that the Hon. John Douglas C.M.G. had special gifts and his power to influence others was at all times, devoted to the service of his church. A Durham man of considerable learning, he was a capable and industrious administrator. He came of the family of the "Marquis of Queensberry", was mild mannered, but had an extreme degree of obstinacy! His full and sonorous voice was a delight to the ear and at one time, he gave the public the full benefit of it in a series of readings from ecclesiastical history. He was Premier of Q'ld. from 1877-1879, Agent-General in London, Administrator of New Guinea and finally, Government Resident on Thursday Island from 1885 until his death in 1904. He remained Trustee of All Saints' Church from 1865 until his death and for many years acted as a Synodsman and was also one of the first wardens.

**Archibald Douglas** was the third child of James & Janet Douglas nee Torry and was born at Sandown Barricks, Isle of Wight, 14/Sep/1802, and died Edinburgh 03/Jul/1857 and buried at Dalry Cemetery. On 06/Mar/1844, Archibald was admitted to the Priory of the Lothian's of Knights Templar and constituted a Knight Commander of the Order. He married (1) 09/Apr/1833, Caroline Montagu Scott, daughter of Ebenezer Prentice Scott of Christianstadt. Caroline emigrated to New Zealand with the children and died Mossgiel, 10/Nov/1886. Their issue

1.John Torry Douglas, born 06/Feb/1835, Edinburgh, Scotland and died at Dunedin, New Zealand 23/Dec/1887 unmarried.

2.Elizabeth Campbell Douglas, born 08/Nov/1836; died Mossgiel, New Zealand 13/Sep/1907. She married Dec/1859 Dr Robert Burns, MRCS of Edinburgh. He was one of the first doctors in Dunedin and died Apr/1907.

3.Ann Jean Douglas born 04/Jan/1839; died Mossgiel New Zealand 19/Nov/1898; married 18/May/1858, George Supples of Admiralty Cottage, Newhaven near Edinburgh, Scotland.

4.Margaret Antoinette Douglas was born 30/Jan/1842; died Mossgiel, New Zealand17/Jul/1909; unmarried.

5.Caroline Douglas was born 13/Mar/1845; died Dunedin 17/Jul/1909; unmarried.

6.Helen Brydon Douglas, born 1849; married David Con Hutton of Lorne Lodge, Dunedin, New Zealand.

7.Janet Torry Douglas, born 22/Dec/1851; married 28/Feb/1871, Keith Ramsay one of the founding fathers of Dunedin, New Zealand.

**James Torry Douglas**, brother of Archibald Douglas and son of James & Janet Douglas nee Torry was born Castle Cornet, Guernsey the 3<sup>rd</sup> or 23<sup>rd</sup> Feb/1804; died Edinburgh 06/Jan/1877; buried Dean Cemetery, Edinburgh; writer of the Signet and searcher of Public records at Register House Edinburgh. On the 27/Feb/1867 James and his brother John David Wilber Douglas formed the company of Douglas & Co. at Edinburgh. In 1868, James joined the Freemasons and was admitted to the Priory of the Lothians as Knight Companion and the following year was promoted to the rank of Knight Commander.

James Douglas married (1) St Cuthbert's Church, Edinburgh 17/Oct/1831, Helen Brydon Brown, daughter of Alexander Brown of Whitesome, Berwickshire. They had issue

James Douglas married (2) 08/Aug/1869, Anne Duncan Lennie, daughter of James Lennie of Edinburgh. Their family

6.Eliza Brown Douglas born 08/Aug/1870;married Luther A Renner of Manila, the Philipine Islands.



7.Janet Torry Douglas born 29/Dec/1874; married Edinburgh 04/Sep/1900, George Kirk.

**Thomas Harigad Douglas** was the only surviving child of James & Helen Brydon Douglas nee Brown and born Edinburgh 23/Apr/1832; died 30/May/1896; buried Dean Cemetery, Edinburgh; succeeded his father as searcher of public records in Edinburgh; resided at Hermitage Hill, Leith. In 1862, he joined the Freemasons of the Priory of Glasgow and in 1868, he transferred to the Priory of the Lothians and became a Companion 07/Apr/1868. Thomas Douglas married (1) Edinburgh 22/Jul/1863, Jane Catherine Rachel Simpson daughter of Alexander Simpson of Edinburgh. Their family

James Torry Douglas was the eldest son of Thomas Harigad & Jane Catherine Rachel Douglas nee Simpson of Edinburgh and was born 11/Jul/1864; Captain in the merchantile marine and senior partner in the company of Goddard & Douglas Marine Surveyors, Hongkong. James Douglas married Dec/1896, Mary Louise MacGowan daughter of Rev.John MacGowan of Amoy, China. Their family

## Wedding & Courtship Customs

(compiled from "The Journal", Kilmarnock Family History Society, Issue 19, August 2006, p.17)

Courtship and marriage are important in all societies and many customs and rituals have risen as a result. Below are a few such events which used to happen in Scotland and which many of our forebears have brought to the countries in which they chose to live when they immigrated.

## Prophecies

Remember the custom of foretelling your marriage partner? One such event was by paring an apple so that the skin came off in one length. As the clock struck 12, the skin was swung round the head and thrown over the left shoulder. When it landed it would form the first letter of the name of the future spouse. Another such custom was the burning of two nuts in a fire. If they burned quietly then all would be well but if they exploded and burst, true love would be hard to find.

## Valentine Dealing

On 14 February an equal number of male and female names were written on bits of paper and placed in separate containers. Each person drew out a name from the appropriate tin. Whoever became paired were sweethearts for the following year. The modern custom of sending Valentine cards stems from this arrangement. Modern envelopes have "Postman, postman, do not tarry, take this to the girl I'll marry" and "SWALK" (sealed with a loving kiss) and/or HOLLAND (how our love lasts and never dies) written on them. Courting/winching

Going out together was a popular activity for the young men and women and still is. Everyone would gradually pair off but in the old days, when they became engaged, they stood on opposite sides of a burn, dipped their hands in the water and joined hands.

## Bundling

Orkney was particularly active in this custom although it was practised in many parts of Scotland too. The courting couple were encouraged to share a bed — but with a somewhat strange twist to the sharing. The girl's legs were tied and covered securely with a sheet or quilt with the idea being to allow the couple to talk and get to know one another but in the safe (and warm) confines of the girl's home.

## Name Carving

We've all done this at some stage or other. Initials were often carved or written on tree trunks/stones/school desks/toilet doors etc. sometimes surrounded by a heart — DH loves JB.

#### Dance Halls

Ever the popular meeting places for the young in both town and city. It was customary for the men to stand on one side of the hall and girls on the other. When the announcement "Please take your partners for..." was made, there was a mad dash by the boys across the dance floor. The legendary question was "Are ye dancing?" to which the reply was "Are ye askin?" As the evening progressed, there might be a mutual agreement for the young man to 'lumber' a girl home.

The Clan Douglas Association acknowledges that on the list of Sept families there are some who are recognised as belonging to other clans, but some families of these surnames were closely linked with branches of the 'Douglas' in the early years.
